Notice Inviting Expression of Interest for Project Proposals under Deen Dayal Upadhyaya Grameen Kaushalya Yojna (DDU-GKY) in the State of Nagaland

National Rural Livelihoods Mission (NRLM), MoRD GOI is implementing placement linked skill development program under Deen Dayal Upadhyaya Grameen Kaushalya Yojna (DDU-GKY). Nagaland State Rural Livelihoods Mission (NSRLM), Rural Development Department Nagaland is the Nodal Agency for implementation of the program in the State.

NSRLM invites proposals from registered Project Implementing Agency (PIA) with valid Permanent Registration Number (PRN) No.(MoRD, GoI) for implementation of DDU-GKY Project in the State of Nagaland for skill training and placement of 6924 beneficiaries for the year 2017-20. Interested Agencies may submit their proposal online at [http://www.rural.skills.in./](http://www.rural.skills.in/) along with application fee of ₹25,000/- drawn in favour of **NSRLM (DDU-GKY), SBI Sect. Further, project appraisal fee will be applicable to the applicant PIA separately as per Notification No. 20/2017 Dated 3rd April 2017, Rural Skills Division of MoRD, Government of India.

The proposals should be submitted on or before 20th June, 2017, application received after aforesaid date shall not be entertained in this round of appraisal. Incomplete proposal in any respect shall be summarily rejected.

Training duration will be for 3 months, 6 months, 9 months and 12 months. As per target assigned by the Ministry of Rural Development, preference will be given to long term duration course (residential) and to agencies providing captive placement and only those PIAs with training centres in Nagaland will be entertained.

PIAs are encouraged to apply for projects in the following sectors


